NO REFUNDS on registration balance will be given after the first full week of practice for your child.

If your child registers after the first day of practice – NO REFUNDS will be given after the first full week of his/her practice.

Registration fee includes: first mouthpiece, (1) pair of game socks, personalized game jersey, insurance, team and individual pictures, awards banquet ticket and award, plus the use of the equipment listed above. Cheerleaders receive boy briefs, crop top, socks, insurance, pictures, awards banquet ticket and award, plus use of the equipment for cheering.

MANDATORY FUNDRAISER: \$120.00/per child for one book of 12 raffle tickets at \$10.00 per ticket. Raffle ticket books will be issued to you at equipment pick up day in July. **YOU MUST PAY FOR THE BOOK OF RAFFLE TICKETS AT THIS TIME.** Each child can sell their tickets to family, friends, coworkers, etc. **Each family will keep all monies received from sold tickets.** Raffle ticket stubs are due back to the Palos Stars on or before Friday, August 30, 2024 to be entered into the drawing for the cash prizes listed on the tickets.

REFUNDABLE WORK COMMITMENT FEE: \$200/family **REFUNDABLE** **AFTER 6** hours of work/per family is completed. Refund will come at end of the season, only if 6 hours per family are completed. Work opportunities will be shared at beginning of the season and you will need to reserve your jobs in advance. Any jobs not claimed will be assigned to families that still need hours. If you are unable to complete the assigned job, you must find a replacement worker. It will be your responsibility to sign in on the days you work, or no credit will be given. Any family that knows they will be unable to complete the hours can opt out of work by paying nonrefundable \$300, instead of the \$200 deposit. No job will be randomly assigned to you if your family has opted out.
